Industry Overview

- **With 5G application being extensive commercial use, 5G's innovation in smart applications has become a new industry development type. 5G applications continue to drive optical fiber cable business opportunities and demands for information and communications integrated services.**
- **The government continues to strengthen national critical infrastructure and promote six core strategic industries including 5G, digital development, AI, and information security, etc. It also expands related plans for digital transformation and environmental sustainability.**



Operation status

- In order to expand the system integration business, the board of directors approved the pre-purchase of 1,838.10 square meters of real estate at lot 36, Xinzhi Section, Xinzhuang District, New Taipei City in May 2023. The construction work has entered the final stage and will apply for usage license subsequently.
- The cash capital reduction plan of the subsidiary Taiwan Intelligent Fiber Optic Network Co., Ltd.(Taifo) was declared effective on December 2023. Our Company holds 68.22% of the shares of subsidiary Taifo and received a refund of 312.3 million on March 2024.
- The joint construction project with Founding Construction Development Corp. (Founding) and Ching Tong Investment Co., Ltd (Ching Tong) has started on July 2024. The plan involves the development of two factory-office buildings, with 11 floors above ground and 3 floors below ground. After development, the distribution ratio will be Tai Tung at 31.07%, Ching Tong at 23.93%, and Founding at 45%.

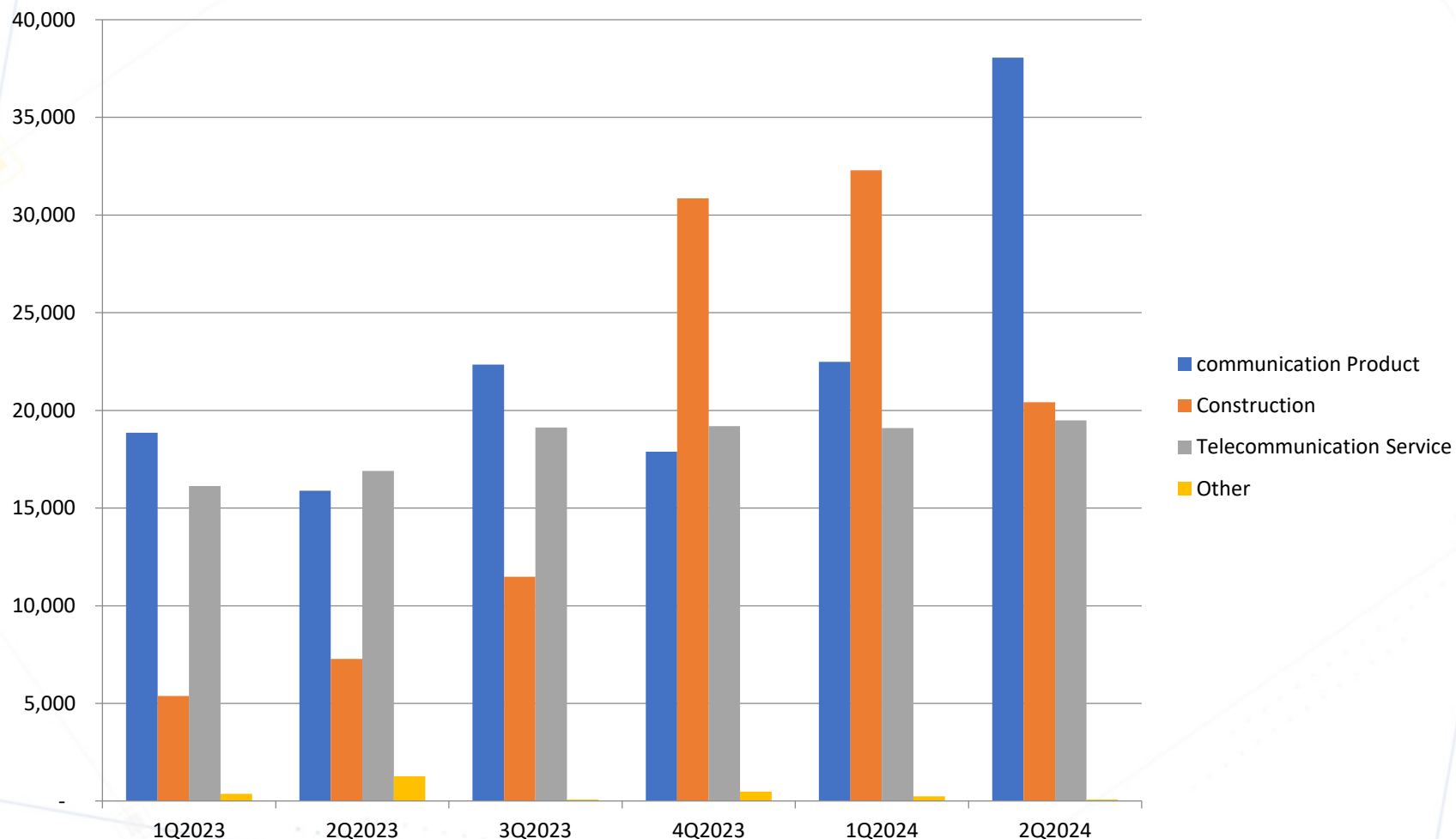

- Founded in 2012
- Current capital : NT\$1.83 B
- Number of employees : 134
- Major shareholders: Tai Tung 68.22% and Hon Hai Group 20.58%
- 25-years BOT contract with Taipei City Gov. starting from 2011
- Nearly 6,000KM Optical Fiber has been built in Taipei since 2012

Note : The amount of paid-in capital was NT\$2.289 Billion. On Dec 26, 2023, Taifo was declared effective to implement capital reduction amounted to NT\$0.458 billion with cash payment to shareholders.

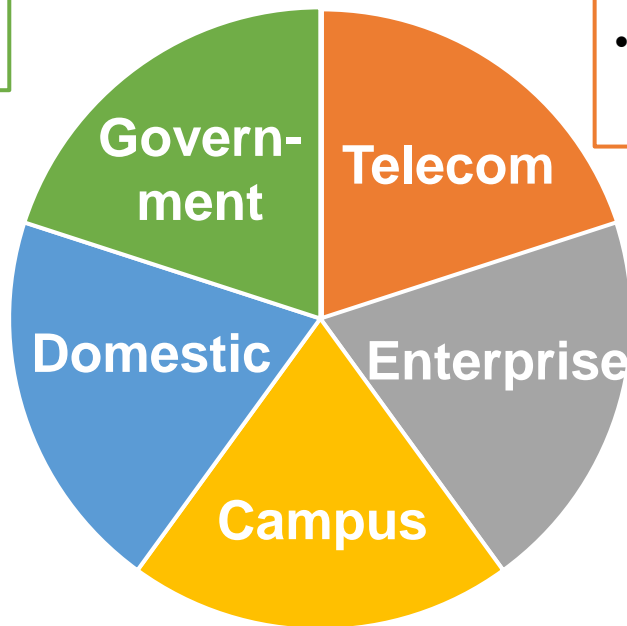
