- SG enters the business operation officially. Along with countries continueing building infrastructure of 5G, the demand for optical communication and passive components increases because bandwidth upgrades continuously.



#### **Business Development Strategies**

- Carriers: Best partner for 5G deployment
  - Provide low fee/high bandwidth services to help fast deployment upon various locations(lamppost/gov. buildings/community buildings)
- Enterprises: Low fee for carrier-grade network services
  - Offer low fee for carrier-grade network services to differentiate with cable system operators', and sell though ISPs
- Consumers: Neutral Contents provider to consumers
  - Low fee/high bandwidth for services and neutral contents to consumers.

- 7X24 operations and maintenance

- BOT contract allows TAIFO to utilize city governments' limited drain and pipe resources for fiber optic network deployment
